

Revising an Order

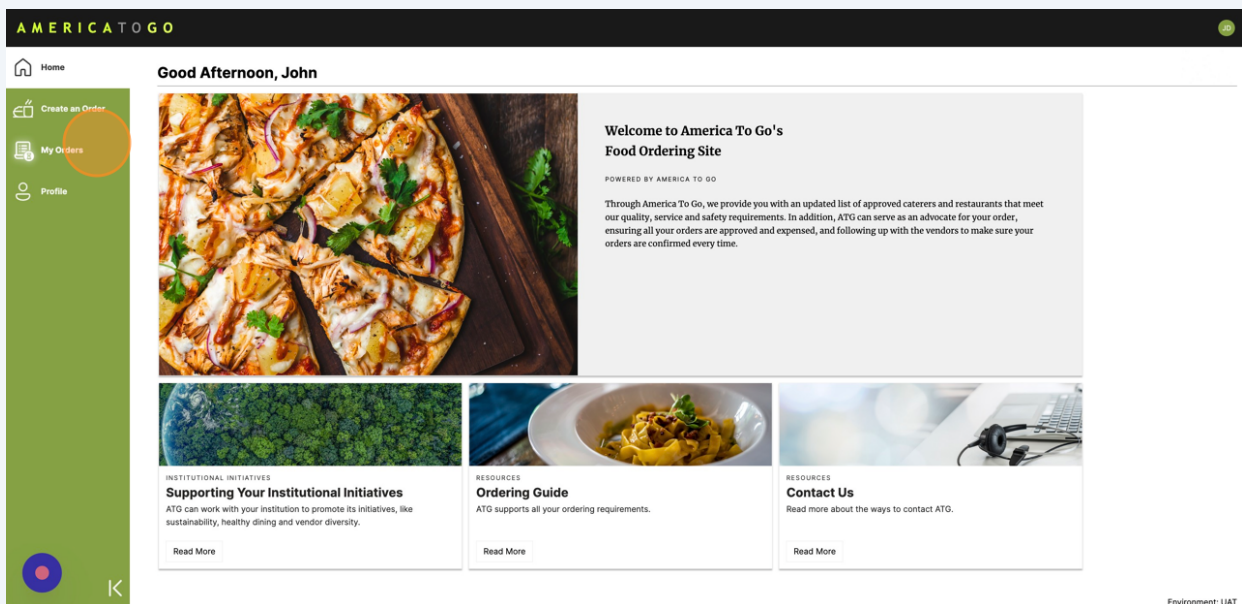
This guide provides step-by-step instructions on how to revise an order in the America To Go ordering platform.

It includes information on how to revise your order when the vendor has already confirmed the original version, including any restrictions you may have on revising your order outside the vendor's normal revision timeframe.

Finally, you will see how to track your revision and get help from ATG Customer Service if you need.

1 Go to your ATG ordering homepage.


2 Click the "My Orders" page in the side menu.

On the order you want to revise, click the three-dot icon or right click anywhere on the row to open the action menu.

Requesting a revision means that you will need to wait for the vendor's confirmation that the order can be fulfilled as revised.

5 Edit your shopping cart as needed.
